METHOD OF USE

Note: A small trial should be carried out to ensure that the surfaces will not be attacked before cleaning commences

- Moisten rag or cotton wool with **Cleaner 10** and wipe the contaminated surface, avoiding surface recontamination by frequently changing the rag/cotton wool.
- Allow residual solvent to dry before carrying out subsequent operations.

STORAGE

Store in original sealed containers in a dry, well ventilated, flameproof place between 5 - 25°C.

SHELF LIFE

At least 2 years from date of manufacture, under the above conditions of storage.
